# ALTERNATIVES TO IMMIGRATION DETENTION IN THE EUROPEAN UNION: THE TIME FOR IMPLEMENTATION

Organized in the framework of the Made Real project (<a href="http://www.ulb.ac.be/assoc/odysseus/MADEREALuk.html">http://www.ulb.ac.be/assoc/odysseus/MADEREALuk.html</a>), this conference provides a comprehensive understanding of the EU legal framework on alternatives to detention (ATDs) for asylum seekers and migrants and presents a broad range of practices in selected Member States. The results of the research conducted in the framework of the project will be presented by the coordination team and project partners, together with interventions from practitioners, judges, academics from several EU Member States as well as representatives from EU institutions and international organisations.

The first panel will analyse the notion of ATD in order to get a better understanding of it in the EU context. The second panel will examine if and how ATDs become part of the administrative decision making process and of judicial control. The final panel will present the opportunities and challenges raised by the practical implementation of ATDs to detention in several Member States.
