

# The Temporary Protection Directive: Central Themes, Problem Issues and Implementation in Selected Member States

Seminar at the Centre for Migration Law Friday 20 January 2023, Nijmegen, The Netherlands

In response to the aggressive invasion by the Russian regime in Ukraine, the EU Member States acted swiftly with the activation of the Temporary Protection Directive (TPD), for the first time since its adoption in 2001. As of 4 March 2022, the Temporary Protection Directive applies to the approximately 4,5 million refugees from Ukraine residing in the EU. The Directive aims to secure a more equitable responsibility sharing and swift access to rights and services.

After almost a year after the activation of the TPC it is time to take stock. How is the current situation of the Ukrainian refugees? And what are lessons for – perhaps – future activations of the TPD.

This seminar is trying to shed light on the working and future of the TPD.
