The Commission considers the creation of this one year programme of training as an interesting contribution of the academic community to the development of a common policy on immigration and asylum. There is indeed a growing need for specific training on those issues in the Member States and offering training opportunities is also a significant element of capacity building for third countries cooperating with the EU to improve immigration and asylum management.

TEACHING ORIENTATION and METHODOLOGY



The programme is of a legal nature and very demanding. Courses will be rather technical in orientation. but the first module is an introduction follow it successfully bv non-iurists acquiring EU institutional framework; the interactions between human and migration & asylum law; the roots of EU law in international migration & asylum law; and the freedom of movement of EU citizens by comparison with thirdcountry migrants; the law of the external relations of the EU. Participants will benefit from the companion Odysseus Research Handbook on EU migration and asylum law' that provides an helpfull overview of the basics for all the subjects of the courses.

On top of the executive master, the fees cover access to the Odysseus summer school participants the possibility acquire the necessary basic to knowledge before following the executive master. The classes offer theoretical but practical elements, in particular regarding the case law of the EU Court of Justice and of the European Court of Human Rights. Personal reading is expected from the participants. very latest developments of the European policies

are integrated into the teaching through the participation **lecturers** of highas officials **European Commission**, Council, ranking from the **Parliament** and EU agencies. Participants will follow the day-to-day developments of the EU policy by receivina information from the Odysseus team.

The classes will be conducted by academics among the best specialists of EU and national migration asylum law. **Three** specific gatherings including the professors, other members of the Odysseus Network and high-ranking officials from the EU institutions are Brussels throughout the year to give the participants organised in physically. Specific issues will be discussed during the occasion meet and exchange these meetings order improve the understanding of participants and illustrate in to courses.

The classes gather participants online from all over Europe who will benefit from broadcasting technology. Courses are recorded to allow participants to follow them when they are not available during classes. A short training will be provided to learn how to use the Teams platform.

Participants only need to have a **good internet connection** and a computer with a camera. The participants will have access to an online platform providing access to an extensive and up to date documentation.

RESEARCH OPPORTUNITIES

Participants have to write for the final exam a blog post that must be analytical rather than descriptive. The subject to be selected in agreement with the coordination team must deal with EU or comparative law with an EU dimension. The best posts will be published on the Odysseus blog so that the selected participants will have a scientific publication to add on their CV. The fourth term corresponds to a research track during which participants draft their blog post with the support of a member from the Odysseus Network. Interested persons will obtain advice on how to build a subject for a PhD. We also offer the opportunity to do a traineeship in the Brussels coordination team of the Odysseus Network.

SCHEDULE AND LOCATION



This program starts on 1st September 2023, ends on 12 July 2024 and is divided into 4 terms. Courses amount generally to a total of 12 to 18 hours spread over a two/three-week period with sessions of 3 hours. The schedule of courses (6 to 9pm on Fridays and 10am to 1pm on Saturdays) enables professionals to participate.

Participants will follow the courses online in real-time through a E-platform. The meetings requiring physical presence will take place in Brussels.

ASSESSMENT and EXECUTIVE CERTIFICATE

Separate written or oral examinations will be organised for each of the five courses of the introductory module. Another general oral exam covering migration and asylum law will be held for the two specialised modules before a jury composed of members of the Network in the framework of the Odysseus "Summer School on Migration and Asylum Law and Policy of the EU" which takes place every year in Brussels during the two first weeks of July. Participants need to present their blog post during this exam.



Participants who have followed the program assiduously throughout the year and successfully passed the exams will receive an executive certificate corresponding to level 7 of the European Qualifications Framework. It will be delivered on behalf of the Odysseus network as an association having a legal personality.

ADMISSION REQUIREMENTS

Entrance to the course is competitive and based on academic merit and potential. In addition to a good knowledge of English, applicants must have as a minimum a university master's degree (MA) in Law, Political Science, European Studies or International Relations. Applications of graduates of other disciplines will be considered case by case. Applicants can also rely upon relevant professional experience (for example as a civil servant, NGO employee, etc.). They will be required to supply supporting documents. Interviews can be organised in case there is a doubt about the fulfillment of the admission requirements, including knowledge of oral and written English. As well as your CV, a statement of purpose of one page (single spaced, 12 point font) is required to explain your motivation for following the program.

REGISTRATION and FEES

For notice, the program is entirely self-financed by the registration fees paid by the participants and does not rely on any subvention!

The closing date for applications has been set for 1 July 2023. Late applications will be considered if some places are left. Applicants are requested to apply by using the registration form available on the website of the Odysseus Network.

They must pay 1000 Euros for 1 July 2023 to hand in their file.

This sum will not be reimbursed if the participant drops out without a reason of force majeure.

The registration fee is 2600 Euros for students, 3600 for PhD students, researchers or trainees remunerated by a salary or a grant, and 5500 Euros for professionals. Persons choosing only one specialised module (migration or asylum) on top of the introductory module will respectively pay 2000, 3000 or 4500 Euros. The fee covers all classes, documentation, one paper copy of the Odysseus Handbook and food during gatherings in Brussels (without travel and accommodation costs), including free access to the Odysseus summer school. The Network provides one grant to allow a selected applicant to participate free of fees who will be asked to help for the coordination of the program, and can assist accepted applicants by providing them with proof of access addressed to the institutions from which they intend to request financial support.
