# PRESENTATION

The aim of the program is to provide participants with an in-depth understanding of the legal rules on migration and asylum adopted by the EU. It is of interest to all persons who wish to acquire such specialised knowledge, for instance, EU or national civil servants, lawyers or judges, workers from international organisations and NGOs, researchers and PhD students who frequently confront the complex legal dimension of migration and asylum in their work. The program is organised by the Odysseus Academic Network for Legal Studies on Migration and Asylum in Europe, one of the leading research and training organisations in EU migration and asylum law, founded in 1999 with the financial support of the European Commission.

The program offers the opportunity to live in a unique EU bubble with professors coming from several Member States, as well as speakers from EU institutions. It offers an intellectually stimulating experience as part of a group of fifteen participants specialising in migration and asylum with diverse backgrounds and coming from all over Europe.

Upon completing the Master's program, our graduates can value the technical knowledge they have acquired in migration and asylum law on the labour market. They work for European institutions and agencies, international organisations, NGOs, migration law firms, and national ministers for home affairs. The Executive Master's has also enabled our graduates to reorient their careers towards migration and asylum.

There is indeed a growing need for specific training on those issues in the Member States and offering training opportunities is also a significant element of capacity building for third countries cooperating with the EU to improve immigration and asylum management.*


Vice-President Franco Frattini, Commissioner responsible for Freedom, Security and Justice noted: “The course provides the opportunity to live in a unique European environment, with instructors coming from academic institutions in many different Member States as well as from the EU institutions, and to take part in an intellectually stimulating experience as part of a group of 30-40 participants specialising in the area of immigration and asylum with different backgrounds from all over Europe. I look forward to handing out the first certificate to the students in July 2007”

The programme which is the first of this kind, will offer its participant a deep understanding of the developing European Law on Immigration and Asylum from a theoretical as well as practical point of view. It is made of one introductory module followed by two specialised modules on immigration and asylum and a research paper.

The “Odysseus Network” is the Academic Network for Legal Studies on Immigration and Asylum in Europe” created in 1999 with the financial support of the European Commission. The courses will start in September 2006 in Brussels and are given in English. All information is available on the website

# TEACHING ORIENTATION AND METHODOLOGY



**The program is legal in nature and very demanding. Courses will be rather technical in orientation**, but the introductory module allows non-jurists to follow it successfully by acquiring knowledge on the EU institutional framework, the interaction between human rights and migration & asylum law, the roots of EU law in international migration & asylum law, the freedom of movement of EU citizens by comparison with third-country nationals and the law of the external relations of the EU.

Participants will benefit from the companion Odysseus Research Handbook on EU migration and asylum law, which provides a comprehensive overview of the basics for all subjects covered in the courses.

**On top of the Executive Master, the fees cover access to the Odysseus Summer School, taking place every year in Brussels as well as online during the first two weeks of July, to allow participants to acquire the necessary basic knowledge before starting the Executive Master.** The classes offer both theoretical and practical elements on the case law of the Court of Justice of the EU and the European Court of Human Rights. Personal reading is expected from the participants.

**The very latest developments of EU policy are integrated into the teaching, in particular through the participation as lecturers of high-ranking officials from the European Commission and the European Court of Justice.** Participants will follow the day-to-day developments of the EU policy by receiving information from the Odysseus team. The classes will be conducted by academics among the best specialists of EU migration and asylum law. Three specific gatherings, including professors and experts from EU institutions, are organised in Brussels throughout the year to allow participants to meet and exchange in person. Specific issues will be discussed during these meetings to improve participants' understanding and illustrate the courses.

**Attendance at online classes is mandatory** to ensure interactivity between participants and professors. The coordinator will monitor participants' attendance, and those who are frequently absent without a valid reason for force majeure will not be allowed to take the exams. **Class recordings** are provided to support the learning process, but they are not a substitute for attending the live sessions.



Participants only need to have a good internet connection and a computer with a camera. The participants will have access to an online platform providing an extensive and up-to-day documentation.

## RESEARCH OPPORTUNITIES

For the final exam, participants have to write a blog post that must be analytical rather than descriptive. The subject to be selected in agreement with the coordination team must deal with EU or comparative law with an EU dimension. The best posts will be published on the Odysseus blog, so that the selected participants will have a scientific publication to add to their CV.

The fourth term corresponds to a research track during which participants draft their blog post with support from a member of the Odysseus Network. Interested persons will receive advice on how to develop a PhD research topic. We also offer the opportunity to do a traineeship in the Brussels coordination team of the Odysseus Network.

## SCHEDULE AND LOCATION

The program starts on **4 September 2026** and ends on **10 July 2027**. It is divided into 4 terms. The courses amount generally to a total of 12 to 18 hours spread over a two/three-week period with sessions of 3 hours. The schedule of courses (6 to 9 pm on Fridays and 10 am to 1 pm on Saturdays) enables professionals to participate. Participants will attend the courses online via Teams. Only the three gatherings require physical presence in Brussels.

## ASSESSMENT AND EXECUTIVE MASTER'S DEGREE

**Three online written exam sessions** will be organised: one for the introductory module, one for the specialised module on migration, and one for the specialised module on asylum. On top of that, a final **online oral exam** will also be held during the first two weeks of July. This oral exam will include the presentation of the blog post and questions on the specialised modules on migration & asylum, and will be conducted before a jury composed of members of the Network.

Participants who have followed the program assiduously throughout the year and successfully passed the exams will receive an executive degree corresponding to **level 7 of the European Qualifications Framework (EQF)**. It will be delivered on behalf of the Odysseus Network as an association having a legal personality.

## ADMISSION REQUIREMENTS

**Entrance to the course is competitive and based on academic merit and potential.** In addition to a good knowledge of English, applicants must have a minimum of a university master's degree (MA) in Law, Political Science, European Studies or International Relations. Applications of graduates of other disciplines will be considered on a case-by-case basis. Applicants can also rely upon relevant professional experience (for example, as a civil servant, NGO employee, etc.). They will be required to provide supporting documents. Interviews can be organised in case there is a doubt about the fulfilment of the admission requirements, including knowledge of oral and written English. As well as your CV, a statement of purpose of one page (single-spaced, 12 font) is required to explain your motivation to attend the program.

# REGISTRATION AND FEES

**For the record, the program is entirely self-financed by participants' registration fees and does not rely on any subvention!**

**The closing date for applications is 10 July 2026** via the link below. Late applications will be considered if some places are left.

Applicants **must pay 1000 € by 10 July 2026 to officially submit their application**. This sum will not be reimbursed if the participant drops out without a reason of force majeure.

The registration fee is:

- 2600 € for students
- 3600 € for PhD students, researchers or trainees
- 6000 € for professionals.
- Persons choosing to attend only one specialised module (migration or asylum) in addition to the introductory module will pay 2000, 3000, or 4500 €, respectively.

Classification of individuals as students, PhD researchers, or trainees is based on their salary level. It is required to provide proof of your eligibility for the chosen category. If you receive a salary, Odysseus will determine which category you belong to. Please note that individuals with a regular salary do not qualify for these categories.

The fee covers all classes, documentation, one paper copy of the Odysseus Handbook, and food during gatherings in Brussels (excluding travel and accommodation costs), as well as free access to the Odysseus summer school **BEFORE** the start of the Master's. The Network provides one grant to allow a selected applicant to participate free of charge, who will be asked to help with the coordination of the program.
